



The Law Society establishes statewide standards, regulatory frameworks, and resources that the RLS can utilise, while also providing a platform for regional concerns to be communicated at a broader level. # CLARENCE RIVER & COFFS HARBOUR LAW SOCIETY INFORMATION

As a legal practitioner in the Clarence River & Coffs Harbour region, you are eligible to join the Clarence River & Coffs Harbour Regional Law Society. Membership is renewable annually in March, with fees of \$150 for principals, \$100 for employed solicitors, and \$50 for law students.

The Clarence River & Coffs Harbour Regional Law Society hosts a range of Continuing Professional Development (CPD) events and networking opportunities throughout the year, where members can earn CPD points. Members benefit from discounted event fees, with some events offered for free. The RLS Annual General Meeting takes place each February, and the executive committee meets regularly to address issues affecting local practitioners.

Prospective members can look forward to events, such as CPD workshops, guest speaker presentations, networking and social gatherings.

#### • Annual General Meeting (AGM):

#### The Grafton Show



# Q. What is your advice for early career lawyers who have recently moved?

- Have a set response when clients approach you at the beach or the supermarket. You will run into them everywhere, so it's important to maintain boundaries to avoid any risks associated with a lack of file noting, etc.
- Learn how to manage client interaction outside of the workplace.

### What exciting road trips would you recommend in your region?

- A trip to the Promised Lands near Bellingen is nice, especially in summer when the weather is perfect for swimming.
- The drive down south to Southwest Rocks, passing through Stuarts Point and Grassy Head, is great.
- The drive to Bellingen and up the mountain to Dorrigo National Park.
   There are great bushwalks there.
   On the return trip to Coffs Harbour, take the road through Megan and Coramba.
- The road northwest to Tenterfield in the autumn is stunning.
- Up north, you can visit Red Rock, passing through Woolgoolga and Corindi Beach. To the west, you can head to Glenreagh through Coramba. You can't go very far east, though, as you will end up in the Pacific Ocean!

- Grafton closes early, but sitting overlooking the river at the Crown is hard to beat.

- The Coast is open the latest, but there are some cool spaces at King Tide Brewing, and in Sawtell, like the Athletic Club. There are also pubs galore, which are always great!
